I agree and acknowledge that if it is determined during the follow-up visit that any of the terms and conditions reflected in this agreement are not being met, I will agree to surrender the animal to a C.A.R.E representative upon request. **C.A.R.E DOES NOT PROVIDE REFUNDS FOR VIOLATIONS OF THIS AGREEMENT.**
- 4 **C.A.R.E. Non liability** – I do agree that C.A.R.E volunteers, representatives, agents, employees, servants, C.A.R.E facilities, foster homes shall not be liable or responsible for and shall be held harmless by me from and against any and all claims and damages of every kind, for injury to or death of any person or persons and for damage to or loss of property, arising out of or attributed directly or indirectly to the adoption of a pet by me under this agreement, including claims and damages arising in whole or in part from C.A.R.E negligence. I also understand C.A.R.E cannot guarantee the health of any adopted pet. I do understand C.A.R.E rescues stray, abandoned and homeless animals. We provide shelter, immediate medical care as necessary and foster the animals until an approved adoption is complete. C.A.R.E has no means of knowing the full health or history of the animal. I hereby release C.A.R.E of their responsibility for this animal and agree to the terms of this Community Animal Rescue Effort Adoption Agreement.
